

3. The University shall not be responsible under any circumstances for any sort of postal delay.
4. Persons already in employment should apply **Through Proper Channel** and must produce **NOC-cum-Vigilance Clearance Certificate** from their present employer with proper channel form or at the time of interview in prescribed performa annexed as **Schedule-II**. Failing which their candidature will not be considered.

In the event of total marks obtained from educational qualifications and interview being the same, candidate having higher marks in educational qualification will be placed higher in the final merit list. Subsequently, In the event of candidate having same educational qualification marks, candidates who are elder in age according to the date of birth will be placed higher in the final merit list and in the event of candidates having same date of birth, candidates whose name appear alphabetically first in Devnagiri Script will be placed higher in the final merit list.

## **GENERAL TERMS & CONDITIONS:**

**NOTE: Before filling-up the Application Form, the candidates are advised to read General Terms & Conditions, Essential Qualification and Other Important Conditions carefully.**

1. In service candidates should submit their original applications through proper channel. However, an advance copy with requisite fee must reach the Officer-in-Charge, Recruitment on or before closing date and time. Application received after closing date will not be entertained. Application duly forwarded by the competent authority must reach Recruitment Cell, BAU, Sabour within a fortnight of closing date / up to **31.08.2024**.
2. Application fee for the post of Associate Professor-cum-Senior Scientist/Senior Scientist-cum-Associate Professor/ Associate Professor have to pay through **SBI e-collect mode only**. Link is available on the university website **www.bausabour.ac.in**. (*Schedule- IV*).
3. Copy of the online payment receipt should be attached with the application form.
4. Application form can be downloaded from the website **www.bausabour.ac.in**
5. No enclosure/certificates will be accepted after closing date of application.
6. Details of the research papers with a copy of reprint are essential to be enclosed. In case of books photocopy of cover page, preface, contents and back cover page be attached with the application.
7. Candidate seeking employment against reserved vacancies must submit caste certificate issued by District Magistrate Physically handicapped persons must submit the certificate of disability issued by the Medical Board of State Government Hospital, if applicable.
8. Candidates must affix a recent passport size self-attested photograph on the specified place in the application.
9. Standard/reputed journal refers to those journals which are having NAAS rating for the year 2024.
10. The candidates are required to submit duly filled application form along with required documents only through registered post/ speed post. **Application sent through any other mode will NOT be entertained.**
11. Fee once paid will not be refunded under any circumstances.
12. The University reserves the right to:
  - i. Withdraw the advertisement at any time without assigning any reason to this effect.
  - ii. Fill or not to fill up the post advertised for any reasons whatsoever.
  - iii. Increase/decrease the number of posts at the time of selection and make appointments accordingly.

13. 16. No interim correspondence shall be entertained.

19. Information uploaded on the University website shall not be provided to the candidate under RTI Act, 2005. 25. The service conditions including pay level and age of superannuation shall be as per University rules.
26. New Pension Scheme will be applicable with subsequent amendments to fresh regular recruited persons.
27. Persons appointed on these posts may be transferred to any equivalent post within jurisdiction of the University.
28. Selected candidates will have to submit a bond on non-judicial stamp paper at the time of joining the service to serve the university for at least three years. No application for outside employment shall ordinarily be forwarded during the bond period of three years.

32. Each Teaching and Non-teaching employee of the University shall superannuate on attaining the age of 65 and 62 years respectively and thereafter no further extension of service shall be given. The retirement age of employee may change in accordance with the decision of the State Government and implemented in the University after assent of the Chancellor on recommendation by the Board of Management.
33. In case of retired persons, Para 10.4 of the university statute will be applicable.
34. Re-employment shall not be granted except in very special circumstances and that under no circumstances, shall it be given beyond the age of 65 years for non-teaching post and 70 years for teaching posts.
35. The person appointed against any post shall be governed by the act/statutes/rules and regulation of the University as framed and amended from time to time.
36. Candidates shall have to produce original certificates/ documents at the time of interview. In the absence of the same, candidates will not be considered for interview.
37. No TA and DA will be paid for appearing in the interview even if the interview is rescheduled/ not held on the scheduled date due to one or the other reasons.


