The National Testing Agency (NTA) conducted the Joint Integrated Programme in Management Admission Test (JIPMAT)–2024 on 6th June 2024 for Admission to Integrated Programme in Management in IIM, Bodh Gaya and IIM, Jammu.

The scores of JIPMAT is being declared today i.e. 12th July, 2024 at https://exams.nta.ac.in/JIPMAT/. Candidates can login to the website and view/download/print their Score Card.

The examination was conducted in **101 Centres in 73 Cities** (including 02 cities outside India in Dubai & Kathmandu) in Computer Based Test (CBT) mode.

The Examination was monitored in the following ways:

- A Central Control Room was opened to monitor and facilitate the smooth conduct of the Examination on the ground. 71 City Coordinators and 92 Observers were deployed.
- Live CCTV Surveillance was carried out at all centres through 937 Cameras. 375 Jammers were installed at the examination centres to prevent unfair practice by the candidates during the examination through mobile or any other electronic device. The NTA also made arrangements for live viewing of remote locations of all examination centres from the Control Room located in the NTA premises of New Delhi. Recording of CCTV Systems was also done.
- In order to stop cheating using mobile networks, Jammers were installed in all the centres to prevent unfair practices by the candidates during the examination through mobile or any other electronic device.

In order to make the system transparent, the Candidates were given an opportunity to see their Question Paper with recorded/marked responses and to challenge the Provisional Answer Keys from 12 June 2024 to 14 June 2024. Challenges received online were placed before the concerned Subject Experts for verification. The result has been prepared based on the Final Answer Keys and the same has been declared on the website https://exams.nta.ac.in/JIPMAT/

The entire examination was conducted smoothly and successfully.

Strict Action including debarment for 02 years has been initiated against 02 candidates on account of using unfair means (UFM).

The eligibility criteria, self-declaration, various documents, etc. of the eligible candidates shall be verified as per norms specified by IIM Bodh Gaya & IIM Jammu where admission is sought, at subsequent stages of the admission process.
