Accordingly, all the candidates, who have qualified for Personality Test (Interview) are required to fill up the Detailed Application Form (DAF), which shall be uploaded on Commission's website separately and same is to be submitted at the J&K Public Service Commission Office at Jammu/Srinagar. The candidates claiming benefit under EWS category shall have to produce the EWS category certificate in Form XIV-A of SRO 518 dated:02.09.2019.
