II. MINIMUM EDUCATIONAL QUALIFICATIONS:

A. Category – II Technician (Diploma) Apprentices:-

- A Diploma in Engineering or technology (Full time) granted by a State Council or Board of Technical Education established by a State Government in relevant discipline.
 - A Diploma in Engineering or Technology(Full time) granted by a University in relevant discipline.
- A Diploma in Engineering and Technology granted by an Institution recognised by the State Government or Central Government as equivalent to above.

III. AGE:

Age limit will be followed as per Apprenticeship Rules.

IV. RESERVATION OF VACANCIES:

Guidelines under Apprentices Act on Reservation for SC/ST/OBC/PwD will be followed. Those who are claiming reservation under SC/ST/OBC/PwD shall provide certificate as per Government standard format, failed which their claim for reservation will be considered as 'General' category only.
