- 5. The provisionally shortlisted candidates will have to mandatorily upload their documents by logging into the website <a href="www.apssb.nic.in">www.apssb.nic.in</a> using their credentials from 12.10.2024 (10.00 AM) to 17.10.2024 (03.00 PM). The following documents are to be uploaded:
  - i. Recent passport size Photograph (2 copies).
  - ii. Matriculation certificates issued by the Board/University for proof of date of birth.
  - iii. Class XII/ Class XII (science) pass certificate (as applicable) issued by the Board/University.
  - iv. Class XII/ Class XII pass (science) mark sheet (as applicable) issued by the Board/University.
  - v. APST Certificate (if applicable).
  - vi. Certificate of 6 months Diploma in Computer Application from a recognized Board/Institution duly recognized by the Arunachal Pradesh Council for Technical Education/AICTE (if applicable).
  - vii. Certificate of 1 year Diploma in Computer Application from a recognized Board/Institution duly recognized by the Arunachal Pradesh Council for Technical Education/AICTE (if applicable).
  - viii. Intimation letter to HoD for those who are in regular Govt. Service.
  - ix. PwD certificate in case of vacancy under PwD quota.



- x. Admit Card and printout of online application form.
- xi. Any other documents as may be relevant.
- 6. Failure to upload documents shall result in rejection of candidature and non-allotment of post.
- 7. The provisionally shortlisted candidates should bring their original documents and photocopy of the documents mentioned at 5 (i) to 5 (xi) along with 02 copies of recent passport size photographs on the day of Skill Test followed by Document Verification.
- 8. The candidature of all the shortlisted candidates is PROVISIONAL and subject to their eligibility in all respects as prescribed in the Advertisement and Recruitment Rules.
- 9. Candidates must note that their candidature is purely provisional at this stage and their appointment will be subject to their name figuring in the final select list which shall be prepared after the completion of PST/PET, Skill (Typing) Test and Document Verification. Apart from that they should fulfil the eligibility criteria as per Advertisement No.6/2024 dated 15.07.2024, including possession of the requisite documents, failing which their candidature may be summarily rejected at any stage.
- 10. Further, the Appointing Authority i.e., the indenting / user department verifies the character and antecedents of the candidates, authenticity of documents/ certificates and eligibility as per the Recruitment Rules before finally appointing the candidate(s). Therefore, the provisional short listing of a candidate does not confer upon him/ her any right of appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.
