- 2. Candidate belonging to specific reserved category from the State of Maharashtra shall be considered for the reserved posts and they are required to submit the Caste Validity Certificate as per the directives issued by the State Government vide G. R. No. BCC-2011/y.sp-1064/2011/16—a, dated 12/12/2011.
- 3. All these posts are created from University Fund and not covered under Grant In-Aid scheme of State Government of Maharashtra.
- 4. The tenure of all these posts is up the end of academic year (i.e. 2025-2026) of concerned course or till the permanent recruitment to be made for the said course/subject, whichever is earlier.

- ➤ Name of the Post Temporary Assistant Professor (for the programme Excluding M.B.A., M.C.A. and M.Tech.) will be as per Government Resolution No. Misc-2018/C.R.56/18/UNI-1 dated 08/03/2019 and its corrigendum, amendments.
- **A.** 1) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
 - 2) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil. / Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET:
